**KIRRA SURF LIFE SAVING CONSTITUTION
SECTION C – PART 2 (Election of Honorary Life Members)**

- (a) Honorary Life Members of the club may be elected from the **members** who have rendered **distinguished** or (10) years **special** service to the club. *(To be considered as distinguished service, service must be both sustained and provide conspicuous contribution).*
- (b) Prospective nominees names and full club service will be submitted by proposer and seconder to be considered by the Meritorious Awards Committee. This committee shall select a nominee who is to be considered by the Management Committee. The successful applicant is then considered for election at the Council Annual General Meeting and a two thirds (2/3) majority of those voting is required to confirm the event.
- (c) Successful nominees for Honorary Life Membership shall be formally announced by the Club President or his nominee at the Annual General Meeting of the Council. A Life Membership badge and a plaque (if considered necessary) may be presented.
- (d) No more than one member shall be elected in any one year.

BY-LAW 3.10 – HONORARY LIFE MEMBERSHIP

Honorary Life Membership may be granted by the club to members who have rendered distinguished or (10) years special service as provided for in the club constitution or By-Laws and is relevant to the club. Refer to 1/C/2 and By Law 1.3

BY-LAW 6.13 – MERITORIOUS AWARD COMMITTEE

To be appointed by the Council at an Annual General Meeting to look at and recommend worthy recipients for meritorious/special awards. This shall comprised of (4) honorary life members of the club.
